NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities

Growing Community Media, NFP was organized on October 15, 2019 as an Illinois not-for-profit corporation. The Organization received its tax-exempt approval from the Internal Revenue Service on April, 13, 2020, effective June 12, 2019. This is the Organization's first fiscal year.

The Organization's chartered objective is to make a positive impact on the communities and neighborhoods it serves by reporting, writing, publishing, and connecting those communities through print and online media. The Organization is currently accomplishing this through the weekly publication of the Wednesday Journal (Oak Park and River Forest), Austin Weekly News, Riverside-Brookfield Landmark and Forest Park Review.

Revenue and Expense Recognition

The financial statements of the Organization have been prepared on the accrual basis of accounting and accordingly reflect all significant receivables, payables, and other liabilities. Thus, revenue is recognized when earned and expenses are recognized when incurred.

Estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Accounts and Unconditional Promises to Give

Accounts receivable represent trade accounts primarily comprised of earned project or contract fee balances. Unconditional promises to give represent amounts committed by grantor agencies that have not been received by the Organization. The Organization is on the allowance method for bad debt recognition. Management determines the adequacy of the allowance for doubtful accounts by regularly reviewing the accounts receivable aging and identifying those accounts which are potentially uncollectible. After all efforts are exhausted, uncollectible amounts are written off. All amounts, net of the allowance, are deemed fully collectible as of June 30, 2020 and are reflected at fair value.

Property and Equipment

Purchases in excess of \$500 and having a useful life of one year or greater are considered for capitalization. Property and equipment are carried at cost and depreciated over their estimated useful lives using the straight-line method.

Business Acquisition

Business acquisitions are accounted for in accordance with ASC Topic 805: *Business Combinations*. Business acquisitions are accounted for by allocating the purchase price consideration to the fair value of assets acquired and liabilities assumed. Goodwill is recognized as the excess of the purchase price consideration over the fair value of net assets of the business acquired. All transaction costs are expensed as incurred.

The results of the acquired business have been included in the Organization's financial statements from the respective dates of acquisition.

Goodwill

The Organization has elected to adopt the private company option to amortize goodwill. Goodwill is subject to amortization over a 10-year life.

Net Assets

The Organization has the following categories of net assets:

Net assets without donor restrictions – This category of net assets includes net assets that are available at the discretion of the Board of Directors and/or management for use with general operating expenses. The Board may designate amounts of these net assets for specific purposes which makes them unavailable for use at management's discretion.

Net assets with donor restrictions – This category of net assets includes net assets whose use is limited by donor-imposed, time and/or purpose restrictions. This category includes, for example, donor contribution to a special publications or content. See Note F for more information on the composition of net assets with donor restrictions.

In-Kind

The Organization may receive services, equipment and material without payment or compensation. Donated services are recognized as contributions if the services (a) create or enhance nonfinancial assets or (b) require specialized skills, are performed by people with those skills, and would otherwise be purchased by the Organization. Materials and other noncash donations are recorded at cost or estimated fair value determined at the date of donation. For the 2020 fiscal year, the Organization recorded donated goods that totaled \$478,000, which is included in contribution of Wednesday Journal stock in the statement of activities.

Support Revenue

Contributions, including corporate grants, received or pledged, are recorded as an increase in net assets without donor restrictions unless specifically restricted by the donor. All donor-restricted contributions are reported as an increase in net assets with donor restrictions and are transferred to net assets without donor restrictions as the restrictions are met. Restricted contributions or pledges, where restrictions are met in the same reporting period, are reflected as net assets without donor restrictions.

Pledged amounts and unconditional promises to give are perpetually reviewed by management. On a case-by-case basis, each pledge is evaluated with regard to revenue recognition, collectability and where applicable, ensuring that donor-imposed restrictions are satisfied on a timely basis.

Cost Allocation

The financial statements report certain expenses that are attributable to more than one program or administrative function. Therefore, these expenses require allocation on a reasonable basis that is consistently applied. The expenses that are allocated include payroll, which is allocated on the basis of estimates of time and effort, as well rent, which are allocated on a square footage basis. Other costs are allocated based on their identification with a specific functional category.

Financial Instruments

U.S. generally accepted accounting principles require disclosure of an estimate of fair value of certain financial instruments. The Organization's significant financial instruments are cash, accounts receivable, unconditional promises to give, note receivable, accounts payable and accrued expenses. For these financial instruments, carrying values approximate fair value.

Income Taxes

The Organization is a not-for-profit Organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation. Due to its tax-exempt status, the Organization is not subject to U.S. federal or state income taxes.

The Organization is required to determine whether its tax positions are more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. The tax benefit recognized is measured as the largest amount of benefit that has a greater than 50% likelihood of being realized upon ultimate settlement with the relevant taxing authorities.

Based on its analysis, the Organization has determined that it has not incurred any liability for unrecognized tax benefits as of June 30, 2020. The Organization does not expect that its assessment regarding unrecognized tax benefits will materially change over the next 12 months.

However, the Organization's conclusions may be subject to review and adjustment at a later date based on factors including, but not limited to, questioning the timing and amount of deductions, the nexus of income among various tax jurisdictions, compliance with U.S. federal and U.S. state tax laws, and changes in the administrative practices and precedents of the relevant taxing authorities.

NOTE B – ACCOUNTS RECEIVABLE AND UNCONDITIONAL PROMISES TO GIVE

The Organization has accounts receivable of \$107,584 and unconditional promises to give of \$159,700 for the year ended June 30, 2020. The Organization's allowance for doubtful accounts receivable and unconditional promises to give are zero for the year ended June 30, 2020.

NOTE C – NOTE RECEIVABLE

The note receivable consists of a transferred asset from the Wednesday Journal acquisition (Note D). It was the result of the sale of the Chicago Parent publication on August 6, 2019. The note is being paid with monthly payment of \$3,472, including interest at 1.91% and matures on September 26, 2022.

NOTE D – INTANGIBLES

On December 31, 2019, the Organization received the contribution of the majority of the outstanding stock of the Wednesday Journal, Inc. The contribution was recorded as a contribution of \$478,000 based on an independent third-party valuation. Wednesday Journal, Inc. was subsequently dissolved and on

June 30, 2020 all of its assets and liabilities were transferred to the Organization, resulting in the recording of goodwill in the amount of \$322,247.

Amortization expense was zero for the year ended June 30, 2020.

NOTE E – PAYROLL PROTECTION PLAN NOTE PAYABLE

The Organization received a loan totaling \$242,500 through the Paycheck Protection Program (PPP). Funds were provided on May 5, 2020 and the covered period of the loan was 24 weeks. Management estimates that all will be forgiven. The Organization has filed their application for forgiveness, but has not yet received confirmation of such. This is shown in the long-term liabilities section of the balance sheet and as cash flows from financing activities on the statement of cash flows. The unforgiven loan portion will need to be repaid having a term of two years with an interest rate of 1% per annum.

NOTE G – LEASES

The Organization leases its office space at 141 South Oak Park Avenue in Oak Park, Illinois. The original lease ran for fifteen years from April, 2001 through October, 2016. On November 1, 2016, they extended the lease to October 2031 at a monthly rent of \$6,000, with increases each succeeding year. The Organization also leases a warehouse, 2000 S. 25th Avenue Broadview, Illinois through April 30, 2022 at a monthly rent of \$12,236. The Organization leases equipment through February, 2022 at a monthly rent of \$304. Rent for these leases was recorded on the books of the Wednesday Journal through June 30, 2020.

NOTE H – LIQUIDITY AND AVAILABILITY OF FINANCIAL ASSETS

The Organization has a goal to maintain financial assets, which consist of cash, accounts receivable and unconditional promises to give to meet, at a minimum, three months of normal operating expenses which is approximately \$330,000. The Organization has the plan to structure its financial assets to be available as its general expenditures, liabilities, and other obligations become due.

The Organization has \$428,315 of financial assets available within one year of the balance sheet date, as of June 30, 2020, to meet cash needs for general expenditures. These financial assets are comprised of cash of \$327,731 and accounts receivable and unconditional promises to give of \$267,284, less those donor restricted for editorial coverage on issues of equity and education within one year of \$166,700.

NOTE I – CONCENTRATION OF CREDIT RISK

The Organization had two donors who accounted for 84% of revenue, gains and other support in 2020.

The Organization maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Organization has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash. At June 30, 2020, cash in one of the accounts exceeded the FDIC insured limits by approximately \$75,000.
